MTTDHT/140/2025 Resolution No. 140

The MTTDHT has the following competencies according to the currently effective regulations, in accordance with Resolution No. 217 of the Doctoral Council of the BDI:<sup>1</sup>.

**Resolution No. 140:** The MTTDHT approves BDI Resolution No. 217 regarding the committees of the public defense of doctoral student WU YUE (Supervisor: Prof. Dr. Katalin György Takácsné) as follows:

- DOCTORAL AND HABILITATION REGULATIONS OF THE ÓBUDA UNIVERSITYBudapest, 2025 (version in force from 29 April 2025),

  IV. RULES OF DOCTORAL TRAINING AND DEGREE ACQUISITION
  - Initiation of the doctoral degree acquisition procedure, workplace discussion. Section 21
  - (2) The draft of the dissertation must be submitted for workplace discussion organized by the competent institute or research center. In the case of individual candidates, the DI designates the place for the workplace discussion. For the discussion, two written preliminary opponent opinions are prepared on the draft of the dissertation with the support of the DIT and based on the request of the head of the Doctoral School taking into account the evaluation criteria listed in Section 22 (5) and in Annex D15/A). The comments arising in them and in the workplace discussion are considered by the author at his/her discretion. Minutes and an attendance sheet shall be drawn up of the workplace discussion, to which the opinions of the opposing party and the candidate's written response thereto shall be attached.

§ 22

(1) For the evaluation of the doctoral dissertation, the MTTDHT, in relation to the technical and natural sciences, and the TÁMDHT, in relation to the arts and social sciences, upon the proposal of the council of the competent doctoral school, invites two official reviewers and review committees. One of the reviewers may not be in an employment relationship with the University. Only one person may be the same between the reviewers of the workplace discussion and the public defense.

#### Public debate (defense) of the doctoral dissertation

- (2) The review committee shall consist of at least 5 and at most 7 members, consisting of a chairman, two official reviewers, a secretary and 1-3 additional members. The chairman of the committee shall be a university professor or Professor Emeritus of the University. When appointing the review committee, 3 alternate members shall also be appointed, including persons who may be asked to replace the chairman and secretary, and at least one possible alternate reviewer.
- (3) The members and alternate members of the committee shall have an academic degree. One of the two official reviewers and at least one of the additional members of the review committee shall not be employed by the University. At most one of the official reviewers may be the same as the pre-opponent of the workplace debate. The official external reviewer shall be a foreign citizen in the case of students admitted after 1 January 2024.
